We have recently received a manuscript copy of research done by Alice E. Davis of 41 Palmetto Dr., DeBary, Fla. 32713. Ms. Davis reports on the descendents of Theodore M. Davis who was born in Oswego Co., New York in 1833. He married on 11 Aug. 1855, Miss Adeline Austin, who was also born in 1833 in New York State. Their marriage in Oswego Co., N.Y. was performed by L. D. Fergusen, Justice of the Peace of Corning, Stueben Co., N.Y.

Thoedore Davis served the Union in the Civil War, enlisting in Co.H, 9th Reg't. of the N.Y. Heavy Artillary on 2 Jan. 1864 in Volney, Oswego Co., N.Y. He died of pnuemonia on 19 Aug. 1864 in the Lincoln Hospital, Washington, D.C. and was buried in Arlington National Cemetary. His wife, Adeline, received an \$8 per month pension until her demise on 27 Oct. 1901. Census records show Theodore and Adeline living in Fulton, Oswego Co., N.Y. in 1860 and she and her two sons residing in Granby of that same county in 1870.

Other surnames of Bay area families in Ms. Davis' work are Maxson (Maxon), Quast, Richter, DeYoung, Stringer, Gust, Noel, Ulman, Stevens, Gustefson, Folgersonger, Hayes, VanEmery, Robinson, Essex, Courneya, Lunsford, Krick, Bartlett, and Arnold along with a number of Michigan and out of state families.

Mrs. Davis and her husband, Wes, both born and raised in Bay City, moved to Oxford, Michigan in 1963, Columbiaville in 1974 and thence to DeBary, Fla. in 1988. Her work has been placed in the society library where it will be available.

We sincerely thank Mrs. Davis for her good work and willingness to share with us. We feel that is extremely important in genealogy.
